### Economic value of Hartpury

Our total impact on the regional economy was £94.9 million in the 2016/17 financial year, which was equal to approximately 0.8% of Gross Valued Added (GVA) of the GFirst LEP area, equivalent to supporting 4,043 jobs.

We're one of the largest employers in the area, with a total payroll of £16.8 million in 2016/17, much of which was ploughed back into the local economy by Hartpury staff.

Hartpury College graduates may earn £410,000 more during their working lives, and Hartpury University graduates £958,000 more, than someone with a less than entry level education working in the UK.

### **FoDDC Business Start Up Grants**

### A new business start-up grant is being launched on 21<sup>st</sup> September 2020.

Grant funding can be used towards a variety of business and social enterprise start-up activity including: research and development, installing clean technologies, premises, equipment and product/service launch.

There will be a maximum of £1,000 per application. Allocation will be agreed on projects at an appropriate scale and the ability to proceed to implementation stage.

Applications will be assessed over 3 rounds in 2020/21 with the closing dates for all applications being:

- 23<sup>rd</sup> October 2020
- 18<sup>th</sup> December 2020
- 26<sup>th</sup> February 2021

# Successful applications must deliver three, or more, of the following 6 desired outcomes:

- New business or social enterprise registrations
- Job creation
- Demonstration of innovation including the design and delivery of new products/equipment/services
- Demonstration of de-carbonisation activity, renewable energy use or the introduction of clean technologies
- Occupation or creation of new commercial floorspace for business us
- Increased footfall / visitor numbers/ visitor spend / turnover for individual business, town or village centre
